## PAYMENT SCAMS

We have seen an increase in payment scam incidents relating to the payment of insurance premiums.

Payment scams can happen to the best of us. Here are a couple of important tips relating to our invoice.

Please be aware that Ausure invoices do not contain a BSB or Account number to pay.

If you receive an invoice that has a BSB and Account Numbers on it, then it's likely a fake invoice.
